- Step 5: Submit your TOEFL scores, if applicable, the address below.
- Step 6: Submit a \$1,000 program deposit to the address below, by July 1. The remainder of the fall tuition is due prior to classes starting in September. The spring tuition is due December 15. All tuition payments are payable to CSU, Stanislaus. Checks may be attached with application materials, or credit card payment may be processed over the phone (209-667-3111).
